#### PennDOT - Notice 2017 Estimated Liquid Fuels Allocation

The Manager acknowledged receipt of the notice of the estimated 2018 Liquid Fuels Allocation in the amount of \$268,567.26. He stated that this is about \$19,000 more than the 2017 allocation of \$249,006. Those funds will be applied to street paving projects.

## Notification of change in the FY 2017 CDBG Schedule

The Manager shared a memo from the City Planner explaining that since DCED has not provided the 2017 CDBG application packet yet, the schedule for public review and final adoption by Council will be changed. The Resolution will be presented for final adoption of the 2017 CDBG Program at Council's October 16, 2017 meeting.

## Update on the 2016 Recycling Collections

The Manager shared an update from the City Planner concerning the PA Department of Environmental Protection (DEP) Section 904 Grant Application. He explained that in 2016 the City recycled 660.70 tons of residential and commercial materials which is 22.46% less than 2015. The decrease is a result of the Clinton County Solid Waste Authority no longer collecting glass as a recyclable material. The deadline to file the grant application to DEP is October 2, 2017.
