ORDINANCE NO. 942

## AN ORDINANCE AMENDING ORDINANCE NO. 670, CHAPTER 15, REGULATING TRAFFIC AND PARKING IN THE CITY OF LOCK HAVEN, IMPOSING PENALTIES FOR VIOLATION.

BE IT ENACTED AND ORDAINED by the City Council of the City of Lock Haven, Clinton County, Pennsylvania, and it is hereby enacted and ordained by authority of the same as follows:

SECTION I. Ordinance 670, Chapter 15, Part 4, Section 15-201, Maximum Speed Limits established on certain streets, be hereby amended as follows:

Delete: "West Fourth Street, between Railroad Street and Fairview Street, 15 MPH School Zone."

SECTION II. Ordinance 670, Chapter 15, Part 4, Section 15-402, Parking Prohibited At All Times in Certain Locations, is hereby amended as follows:

- (A) Amend the first heading to include a subsection number, to read:
  - "(1) Parking shall be prohibited at all times in the following locations:

STREET

SIDE

BETWEEN"

- (B) Add the following subsections:
  - "(2) Within 15 feet of any fire hydrant
  - (3) Within 20 feet of a crosswalk

"Crosswalk" is defined as follows:

a) That part of a roadway at an intersection including within the connections of the lateral lines of the sidewalks on opposite sides of the highway, measured from the curbs or, in the absence of curbs, from the edges of the traversable roadway, that part of a roadway included within the extension of the lateral lines of the existing sidewalk.

- b) Any portion of a roadway at an intersection or elsewhere distinctly indicated for pedestrian crossing by lines or other markings on the surface.
- (4) Within 50 feet of the nearest rail of a railroad crossing.
- (5) Within 30 feet upon the approach of any flashing signal, stop sign, yield sign or traffic-control signal located at the side of the roadway.
- (6) At any place where temporary signs have been posted which were authorized by the City Manager, Chief of Police or their designee.
- (7) Blocking any sidewalk.
- (8) No person shall park or leave unattended a vehicle on private property without the consent of the owner or other person in control or possession of the property."
- (9) Blocking a public or private driveway"
- (C) Add to new subsection 15-402(1), Parking prohibited at all times:

Add: "North Jones Street, West Side, between Iron Alley and Copper Alley."

Add: "West Fourth Street, South Side, between Spring Street and North Jones Street."

Add: "Myrtle Street, Both Sides, from East Park Street eastward to City Line."

Add: "Linden Circle, Both Sides, from Linden Street northward to End."

SECTION III. Ordinance 670, Chapter 15, Part 4, Section 15-403, is hereby amended as follows:

Delete: "West Fourth Street, North Side, between Spring Street and North Jones Street, School Days 8AM-4PM."

SECTION IV. Ordinance 670, Chapter 15, Part 5, Section 15-511(1), is hereby amended as follows:

"§15-511. Penalty for Violations.

1. Any person who violates any provision of this Part, with the exception of §15-509, and who fails to pay the fine set forth in §15-510, shall be cited within 30 days of the violation and, upon conviction, be sentenced to pay a fine of not more than \$15 and costs. The City Manager or his designee shall have sole discretion to waive fines and determination will be made on individual merit."

SECTION V. Ordinance 670, Chapter 15, Part 6, Section 15-612(1), is hereby amended to read as follows:

"§15-612. Penalty for Violation.

1. Any person who violates any provision of this Part, with the exception of §15-609, and who fails to pay the fine set forth in §15-611, shall be cited within 30 days of the violation and, upon conviction, be sentenced to pay a fine of not more than \$15 and costs. The City Manager or his designee shall have sole discretion to waive fines and determination will be made on individual merit."

SECTION VI. Ordinance 670, Chapter 15, Part 4, Section 15-410, shall be amended by adding the following statements:

"Handicapped Parking Stalls:

Any violation of the special purpose parking zones designated as handicapped parking in Section 15-405 shall be subject to a fine of \$50.00 (Fifty Dollars), which will increase by \$10.00 (Ten Dollars) if not paid within five (5) calendar days of notice of violation, and by an additional \$5.00 (five dollars) if not paid within ten (10) calendar days thereafter."

SECTION VII. Ordinance 670, Chapter 15, Part 4, Section 15-405, shall be amended as follows:

Add: "Grove Street, East Side, North of Jefferies Alley, one stall as posted, Loading and Unloading."

SECTION VIII. Ordinance 670, Chapter 15, Part 4, Section 15-413, Manner of Parking, enacted by Ordinance No. 733 of 2005, is hereby re numbered as Section 15-414, and changed to read as follows;

"Section 15-414, Manner of Parking

1. Any vehicle parked either on or adjacent to a roadway, street, or alley shall be parked facing in the direction of travel on the side of the centerline on which the vehicle is parked.

2. Any vehicle parked on a roadway must be parked so that the curbside tires are within twelve (12) inches of the curb."

SECTION IX. All ordinances or parts of ordinances inconsistent herewith be and the same are hereby repealed.

SECTION X. This ordinance shall become effective twenty (20) days after final passage.
