



DEFINITION OF A SECTION 3 RESIDENT

A public housing resident; or

A very low income person as defined to mean families (including single persons) whose incomes do not exceed 50% of the median income for the area.

A low income person as defined to mean families (including single persons) whose incomes do not exceed 80% of the median income for the area, or
