

**NOTICE OF PUBLIC HEARING ON PROPOSED USE OF
COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDS FOR THE CITY OF
LOCK HAVEN’S FFY 2023 CDBG PROGRAM**

Notice is hereby given that the City of Lock Haven will conduct a public hearing at 6:30 P.M. on Monday, October 2, 2023 at Lock Haven City Hall Council Chambers, 20 East Church Street, Lock Haven, PA 17745. The purpose of the hearing is to obtain citizen views and comments on the City's proposed use of \$309,392 in Federal Fiscal Year 2023 CDBG funds and to receive any complaints or grievances regarding the City’s CDBG funds. This meeting is accessible to individuals with disabilities and/or for persons with Limited English Proficiency. The projects proposed for funding and to be discussed at the hearing include:

These proposed activities plan for no displacement of any persons or affordable housing units. The activities will benefit low to moderate income residents.
